# Guidance on Debt Recovery Fees

## Debt Recovery for businesses up to the value of £100,000 - cost and service information

#### **Our Team**

#### **Our Fees**

Our fees for debt recovery for businesses work are based on the time we spend on the matter at the applicable hourly rates in force at the time. They are not dependent on the size of the debt (see Terms of Business <u>here</u> for more information).

We always seek to have work carried out at the appropriate level to be as cost-effective as possible for our clients. Our current hourly rates for this type of work range between the following amounts:

- Partners £550 £650 plus VAT per hour
- Associates £315 £505 plus VAT per hour
- Trainee solicitors £235 £260 plus VAT per hour
- Legal assistants £185 £205 plus VAT per hour

All rates are subject to the addition of VAT at 20% where the work relates to UK land or the client is based in the UK or European Economic Area.

#### **Disbursements**

Disbursements are costs and expenses related to a matter that may, though not always, be payable to third parties, such as court fees. We handle the payment of the following disbursements on behalf of clients on typical debt recovery matters to ensure a smoother process and these are charged in addition to our fees such as:

- <u>Court fees</u> (no VAT is payable on Court fees)
- Counsel's fees (plus VAT)
- Photocopying large numbers of documents (for bundle preparation for example) (plus VAT)
- Courier fees (plus VAT)

The following costs may be also payable which are additional to the charges for our services and the disbursements mentioned above:

- Costs of tracing debtor (if address not known) (plus VAT)
- Costs of e-disclosure specialist providers (plus VAT)
- Expert fees (plus VAT)

#### **Typical costs**

We do not charge fixed fees for this type of work. The costs (and length of time it will take) will depend upon how complex the debt claim is. While we cannot give exact prices for the total cost of the advice, the following ranges are given as a guide for budgeting purposes only.

For a straight-forward debt recovery claim for a known debt (not a damages claim) owed by another business our fees range from around £10,000 to £15,000 plus VAT and disbursements up to the hearing, to about £15,000 to £30,000 for a more complex debt recovery matter with more complicated facts or more than one contract involved for example.

A straight-forward debt recovery claim is one where:

• Documents are all in order (i.e., signed and executed correctly) and not disputed and are provided in a coherent, organised fashion

- Only limited disclosure is necessary (no electronic disclosure)
- Only limited witness evidence is required
- No expert evidence is required
- Assuming half a day hearing with a junior barrister attending (Counsel's fees in addition)

A junior barrister's (up to 2 years call) hourly rate would be between £150 and £250 plus VAT per hour. A more senior barrister's hourly rate would be higher. We would expect junior Counsel's fees for half a day's hearing to range from £1000 to £3000 plus VAT. The facts of the case and number of documents will impact how long it takes Counsel to prepare for the hearing. We will always advise in advance of Counsel's estimated fees.

If successful and the Court makes an order, the costs of enforcing the order (if necessary) will depend on the method of enforcement that is pursued.

These figures may however vary according to the circumstances of each matter. That's why we always give an individual cost estimate at the start of each matter taking into account the features of the case. If complications arise, we will always advise on the potential impact on costs before any additional charges are incurred.

More complex matters will incur further costs such as in a case where:

- Documents are not complete or have not been executed properly
- Papers are not provided in an organised way
- Further investigation and advice in respect of any counterclaim is required
- Expert evidence is required
- Electronic disclosure is required or anything other than limited disclosure
- Conferences with Counsel are necessary
- Multiple witness statements are required
- Tracing the defendant is necessary
- Service other than by post within the jurisdiction is required
- Dealing with insolvency is necessary
- The defendant is acting as a litigant in person
- The defendant is an individual therefore the Pre-Action Protocol for debt claims applies
